BARNARD UNION.

The Union has requested that its Constitution may be republished in the BULLETIN, so that members may have a convenient form to use for reference. It is herewith printed.

CONSTITUTION.

As amended April 12, 1905.

ARTICLE I. NAME.

This organization shall be called the Barnard Union.

ARTICLE II. OBJECT.

The object of this society shall be to further among students of Barnard College the development of literary and forensic activity, to foster among Undergraduate and Alumnae the spirit of loyalty to the College, and the desire to extend its influence abroad.

ARTICLE III. MEMBERSHIP.

SECTION 1. *Enumeration.* There shall be three classes of membership, (1) Active, (2) Associate, (3) Honorary.

SEC. 2. *Eligibility.* (1) All students in Barnard College except Freshmen during the first half year, shall be eligible to Active membership. (2) Graduates of Barnard College shall be eligible to Associate membership. (3) The following shall be eligible to honorary membership:

(a) Officers of the University giving instruction at Barnard who are not Alumnae. (b) Officers of Administration at Barnard who are not Alumnae. (c) Persons who may render distinguished services at Barnard.

SEC. 3. *Admission.* Admission to membership shall take place in the following manner:

(1) Members of the Bear and Debating Club shall be admitted without further election.

(2) Nominations of other candidates for admission shall be made in writing by three members; these nominations shall be passed upon by the Membership Committee, which shall report to the Society at the first regular meeting of each month, these names which shall have been approved by a two-thirds vote of the Committee. The Society shall then vote upon these names separately by secret ballot. The negative vote of one-quarter of those voting shall suffice to reject a candidate for membership.

SEC. 4. *Privileges of Membership.*

(1) All Active members shall have the privilege of voting, except those who have not paid dues. All Active members shall have the privilege of holding office except as hereinafter limited.

(2) Associate members shall have all the privileges of Active members except as hereinafter provided, but only such Associate members as hold office or serve on committees shall have the privilege of voting, except in the case of Graduate officers.

(3) Honorary members may serve on special committees, but shall not otherwise vote nor hold regular office in the Society.

ARTICLE IV. OFFICERS.

SECTION 1. *Enumeration.* The officers shall be:

(1) A Graduate President, who shall be an Associate member.

(2) An Undergraduate who shall be a Senior.

(3) A First Vice-President who shall be a Senior.

(4) A Second Vice-President who shall be a Junior.

(5) A Secretary who shall be a Junior.

(6) An Assistant Secretary who shall be a Sophomore.

(7) A Treasurer who shall be a Sophomore.

(8) A Board of Editors.

(9) The members of the Executive Committee.

SEC. 2. *Duties.*

(1) The Secretary shall be responsible for the performance of all the duties which usually devolve upon such an officer. She shall have charge

In almost every college there is some local market, where the students can buy and sell for their mutual advantage. The "Students' Exchange" is supposed to perform this service for us, but we fear that it does not. Its field is very narrow; second-hand books, candy (only sometimes), class flags (only sometimes), expensive writing-paper and a few odds and ends constitute its stock-in-trade. It is managed by a committee, almost self-appointed, and responsible only to the manager, who in turn is responsible only to herself. This certainly is not as it should be. The Exchange is, we believe, theoretically an important institution, important enough to be recognized as a regular Undergraduate organization. If it were formally recognized as such, if its field were extended, its business properly superintended, its finances audited, it would become a great boon to the college at large. The present manager has worked faithfully to bring order out of chaos, but she has accomplished little more than hint at a future policy. Of course, we do not want the Exchange to blossom out into a full-fledged department store, nor do we want the spirit of commercialism to pervade our college halls, but as long as we have some sort of an "Exchange" it ought to be a real factor in our college life, not a mere trifling incidental.

of the records of the Society and at the conclusion of her term of office shall place in a safe or other place of safety a duplicate copy of the annals of the Society.

(2) The Assistant Secretary shall aid the Secretary, performing such a portion of the duties devolving upon the office of Secretary as they may agree upon.

(3) The Treasurer shall perform such duties as usually devolve upon such an officer.

(4) The Board of Editors shall edit the publications of the Society.

The Graduate Editor and Editor-in-Chief shall be members of the Program Committee.

ARTICLE V. COMMITTEES.

SECTION 1. Enumeration. There shall be the following committees:

I. Executive. II. Program. III. Membership.

I. The Executive Committee shall consist of the two Presidents, two Vice-Presidents, the Secretary, Assistant Secretary, Treasurer, Editor-in-Chief, and three Members-at-large. This committee shall have the functions of a Board of Directors and shall supervise and direct the general business of the Society.

II. The Program Committee shall consist of the Undergraduate President as Chairman, the Graduate President, the First Vice-President, Graduate Editor, Editor-in-Chief, the Secretary and two Members-at-large.

III. The Membership Committee shall consist of two Associate members, the Undergraduate President, and two Active members, each from the Junior and Sophomore classes. The committee shall receive nominations for membership and shall vote upon these and then report to the Society at the first regular meeting of the month.

ARTICLE VI. ELECTION.

SECTION 1. All nominations shall be by secret ballot, and those having the two highest numbers of votes shall be nominees.

SEC. 2. All votes of the Undergraduates for nominations shall be deposited in a box before some officer of the Society between certain hours of the given day in some room of the College buildings.

SEC. 3. The names of the two nominees for each office shall be posted on the bulletin boards in each study at least a week before the election, and shall be printed in the BARNARD BULLETIN in the number preceding elections.

SEC. 4. The voting for the election of the nominees shall be conducted in the same manner as the voting for nominations, and the candidate having the greater number of votes shall be elected.

SEC. 5. Nominations of Officers shall be held during the first week in April.

ARTICLE VII.

SECTION 1. Amendments to this Constitution shall be made in writing at a regular meeting and shall not be acted upon until the next regular meeting.

SEC. 2. Proposed amendments or additions to the Constitution may be adopted only when at least one-half of the Active members of the Society are present, and when three-fourths of those present concur.

SEC. 3. Voting on Amendments shall be by standing vote.

ARTICLE VIII.

SECTION 1. This Society shall publish in a monthly supplement of the BARNARD BULLETIN such literary contributions as seem fitting to the Board of Editors of the Society and to the Editors of the BARNARD BULLETIN.

SEC. 2. The Board of Editors shall consist of five members: Two business editors and three literary editors. One of the literary editors shall be a Graduate, and one of the Undergraduate editors shall be Editor-in-Chief.

SEC. 3. Assistant Editors may be appointed at the discretion of the Editor-in-Chief.

BY-LAWS.

ARTICLE I.

Time of Meeting.—This Society shall meet on the second and fourth Wednesdays of each month at 3.00 P. M. Special meetings may be held at the call of the Undergraduate President on other Wednesdays at the request of ten members.

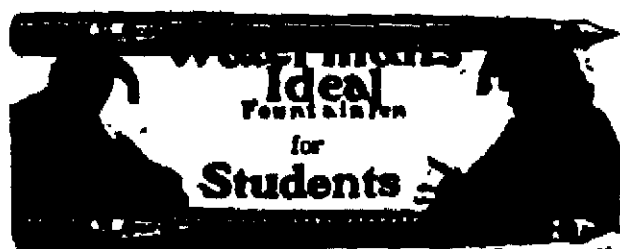

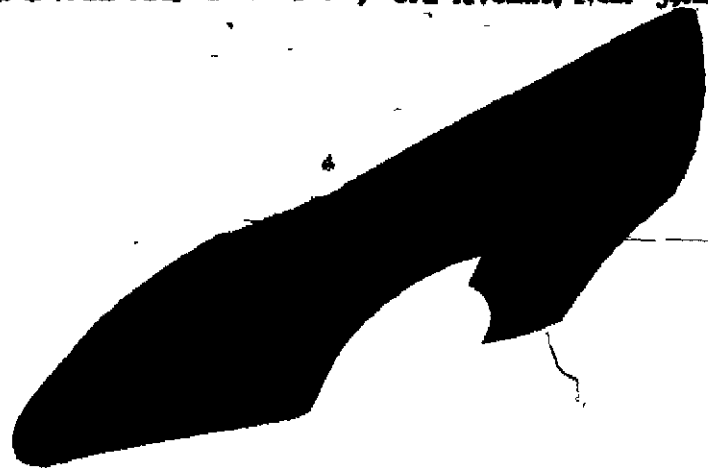

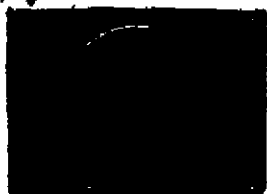
